## To what in the item do you object? Please be specific, citing pages: SEE ATTACHED SPECIFIC PASSAGES FROM THIS BOOK ATTACHED

This book depicts graphic rape scenes, pedophilia and extreme violence toward young girls. Most parents and grandparents will object to the willful placement of books detailing sexually deviant, explicit material anywhere in the minor's section. Taxpayers in Tyler TX have a reasonable expectation that vulgar content will not be displayed or made available to minors by the Library Director or Collections Committee of the Tyler Public Library.

## 2) What do you feel might be the result of using this material?

It is proven that early exposure to sexually explicit, violent material increases the risk of children becoming a victim of sexual violence or acting out sexually against another child. I found this book to be sad and depressing. In the book, the young girl was repeatedly sexually abused. The grown MEN that abused her suffered no real consequences. This is hardly a lesson that should be communicated to young girls or boys.

## 3) For what age group would you recommend this material?

This book should be immediately reshelved in the Adult Fiction. In the Author's Note, it becomes clear the book was written to help bring attention to the fate of Nepali girls. Again, this is something adults would be interested in knowing but should not be available for 12+

year old. There are hundreds of uplifting books about teenagers' struggles that are eventually overcome that are actually helpful to children. Simply because it is about a child does not mean it belongs in the children's section.

## 4) Can you recommend anything good about this material?

The reason that this book reconsideration is being submitted because it is inappropriate for the give minors access to sexually explicit or vulgar books. Whether there is 'anything good' about the material is completely subject and, I believe, irrelevant. Opinions of books vary wildly from person to person. Therefore, I prefer to present only facts by detailing the actual excepts from this book. Graphic, perverted details of the rape of a child should absolutely not be available to minors in the Tyler Public Library.

- 6) Are you aware of the reviews received by this material? The librarian will be happy to help find them.

Yes, I am aware of and have read the reviews of this book including the Tyler Public Library's own rather mild review in its online catalog. I also read the book and have formed my own opinion. I find that reviews from Kirkus and the Tyler Library's catalog to omit the sexually graphic nature of this book. Further, there are multiple online reviews of this book, many of which detail the excerpts as a very good way of warning parents of what is actually in the book. The Collections Committee's job is to clearly understand exactly what type of material they are circulating to minors that enter our library. The City Librarian has the authority to remove any item from the collection and I am requesting this book be removed from the children's section.

Mumtaz pats the edge of the bed and tells me to come closer. The old man makes a clucking sound.

"Don't be afraid," she says. "Come her, now."

I don't move.

Her voice turns hard. "Get over here, you ignorant girl." She says. Still, I don't move.

Then Mumtaz flies at me. She grabs me by the hair and drags me across the room. She flings me onto the bed next to the old man. And then he is on top of me, holding me down with the strength of ten men. He kisses me with lips that are slack and wet and taste of onions. He teeth dig into my lower lip.

Underneath the weight of him, I cannot see or move or breathe. He fumbles with his pants, forces my legs apart, and I can feel him pushing himself between my thighs. I gasp for air and kick and squirm. He thrusts his tongue into my mouth. And I bite down with all my might.

He cries out "Aghh!" and I am running. Running down the hall, past the other girls, losing my fancy city shoes along the way, until I am back in the room where I started, pulling my old clothes out of my bundle.

This book is located in the Young Adult section which includes children from the age of 12 and up.

This disturbing book is <u>filled with sex</u>, <u>racial hatred</u>, <u>murder</u>, <u>drug use</u>, <u>and violence</u>. Throughout the book, sex is referenced as a something to be used by girls as a reward, as a commodity to be traded for expensive items, drugs, cash, for acceptance or mere experimentation. Sex even seems to be entered into out of distrust, competition or fear. For YA children, reading this type of book 'normalizes' this behavior. Throughout this book, sex is treated casually as if trading sex for material items or approval is normal and acceptable behavior and has no real consequences, only rewards. I was stunned by the number of times references of entering into very casual sexual encounters were found. Impressionable YA children have brains that are still developing which is why responsible people protect minors from reading about or viewing sexually explicit acts. I kept expecting a good lesson at the end of the book but was dismally disappointed. The library should be a trusted safe haven and parents have the right to expect books of this kind are **placed in the adult section**.

#### 2) What do you feel might be the result of using this material?

Pervasively vulgar, sexually explicit, violent material adversely affects YA children and youngsters. It can also have a negative effect on a child's own sexual behavior and behaviors toward others. There are many professional and medical publications that prove this that I can provide to the Collections Committee for future reference.

Until recently, Tyler Library patrons viewed the library as a trusted source of information, education, and entertainment. Unsuspecting parents still automatically believe books in the YA children and juvenile's sections are age appropriate because they have been vetted by the Collection Committee. However, we now find multiple examples of vulgar, sexually explicit, violent material accessible to minors.

When questioned, about this, the library leans on the ALA's Freedom to Read Statement. They then point to The Library Parental Responsibility Policy which states "Tyler Public Library supports parents and guardians in their efforts to guide their children's reading, viewing and listening choices".

No one disagrees that Parents guide their children. But tax-payers have every right to expect city employees do not knowingly place crude graphic sexual pictures or content in the YA and children's section.

Taxpayers have a reasonable expectation that the intent and competency of the Collection Committee and Library Director is to ensure minors are not exposed to sexual and violent material. Do to otherwise appears to violate their fiduciary duties.

  This book should be immediately be removed from any areas to which minors have access.

  I found no redeeming qualities or lessons in this book that would justify putting in in an area where YA or children can access it.

#### **EXCERPTS FROM PEOPLE KILL PEOPLE:**

Page 38: "You just want to get laid." ...The gesture moves quickly from "sweet" to "boner-worthy," and as your tongues collide, you lift her off the floor. Another time, you'd carry her into your bedroom.

Page 54: The part-time QuickTrip gig pays minimum wage and you splurged your last check on a little weed, hoping to lower a certain redhead's inhibitions, finally finesse your way into her pants.

Page 101: You underline the promise with a longer, deeper kiss, one to make him believe his effort to take you out tonight will be justly rewarded at its end. That's so much fun that you go a little farther, dipping your tongue lightly into his ear before dropping your lips to his neck, where you lock them in place and suck gently at first, then a little harder. Hard enough to raise a telltale bruise. "Stop already." He steers your hand into his lap, where it's happy to admire the impressive bulge behind his button fly. "I won't be able to walk, let alone dance. Jesus, what you do to me!" "Hey. Jesus didn't do that. I did, and don't you forget it." Hedging his bets, he invites, "Want to do more?" The offer is tempting. Parkinglot sex might be a kick, with or without people walking by. ...They say the only way to keep married sex interesting is experimentation. You'll have to play researcher soon.

Page 119: Throughout those ten years of spiraling abuse, you witnessed her subtle manipulations, designed to divert his rage. Often that meant submitting to him, like a mare to a stallion. More than once it happened within your direct line of sight. That was your sex education. You knew the mechanics by age six.

The worst part now is the two images of her that appear when you let yourself remember: Damian fucking her and Damian killing her.

Page 122 Which is how he almost- too damn close to success- convinced you to have sex the last time you met up.

Page 123: ... Sex has proven to be a useful tool. And beyond that, you like it.

Page 124: The monkey was bartered, sex as commodity. There have been many times when you needed something expensive that you straight-out traded sex for cash.

Page 127: This will be sex as reward. Violence as aphrodisiac. You are totally turned on right now.

Page 128: The mere suggestion of violence serves as intoxicant. Aphrodisiac. Wish more people felt that way. Get down. Get high. Get off.

Page 134: And you didn't get laid. Not last night. Not this morning.

Page 138-139: "Has anyone ever showed you how to feel good?" "What do you mean?" You really didn't know. "Has anyone ever touched you like this?" He pulled you into his lap. One arm remained possessively in control, while his spare hand dropped to stroke the crotch of your jeans. That part didn't hurt and, in fact, you were surprised that your wiener responded positively. Still, you knew it was wrong, so wrong, and you tried to get away. "Oh, no. Not yet." The hand holding you gripped tighter while the other unzipped your pants and yanked them off in one swift, well-practiced motion. You struggled, but couldn't come near to matching his physical strength. He unbuttoned his own fly, freeing his sorry erection to worm its way between your butt cheeks. He slapped a hand over your mouth. "This might hurt a little it's really your first time. Let's see if it is." If there was one small saving grace, it was that he possessed a pencil dick. 

Thank you for your interest in Tyler Public Library and for submitting a Request for Reconsideration regarding your concern for *The Female of the Species* by Mindy McGinnis. A copy of your Request for Reconsideration, as well as a copy of the Library's Collection Development Policy for Reconsideration Appeals process, are attached hereto. Per our process as described in the Library's Policy, the request and item were reviewed by the Collection Development Committee ("Committee") and the results of the review are as follows.

The Tyler Public Library first added this book to its Young Adult collection in March of 2017 on the basis that it met the following specific criteria, outlined in the adopted Collection Development Policy:

- The work was reviewed favorably in professional journals such as Publisher's Weekly, Kirkus, Booklist, Voices of Youth Advocates, and School Library Journal.

- Harper Collins markets this book as a Young Adult read, which matches the review recommendations for an age content level of 14+

Library staff consider professional reviews, awards, and credentials in the process of selecting materials for the collection and each area of the Library. When reviewing material for younger audiences Library staff also reviews age content recommendations. Professional reviewers have rated the content of the work for ages 14+. The Library chose to house this book within the Young Adult section which holds materials recommended for ages 14+ or High School and Young Adult Audiences. Since its inclusion within the Young Adult Section, the book has circulated 16 times.

While the subject matter covers difficult and emotionally charged issues such as rape culture, rural poverty, and vigilante violence and revenge, the Committee responsible for reviewing your request for reconsideration determined, while taking into account the standards established in the Library's Collection Development Policy, that *The Female of the Species* by Mindy is appropriately placed within the Young Adult section (The Young Adult Section is located in a separate area from the Children's section) as it meets several qualifications already listed

The Tyler Public Library believes that it is important for caregivers, parents, guardians, and grandparents to be guides to their children for the materials that they check out. Per the Library's Circulation Policy, parents (or legal guardians) wishing to restrict their children's borrowing of library materials may do so at any time. We understand that not all persons will agree on what should be available to whom, the City of Tyler is bound by federal court decisions regarding the First Amendment, and no one set of beliefs or values can serve as the lens for developing a well-rounded library collection. However, the Tyler Public Library respects all citizen comments and seeks to serve the entirety of the City of Tyler

In conclusion, the Tyler Public Library finds that the inclusion of *The Female of the Species* by Mindy McGinnis within the Tyler Public Library's Young Adult collection is in accordance with the Library's Collection Development Policy. Accordingly, the City's Committee has determined *The Female of the Species* should remain shelved in the Young Adult collection (ages 14+).

As outlined within our Collection Development Policy, if you are in disagreement with the City Librarian and the Committee's decision as explained herein, you may appeal the decision to the Library Board who will review the request within 90 days. Per Section VIII. of the Collection Development Policy:

In making its decision, the Library Board will consider professional reviews and will employ all of the criteria of selection listed in the Library's Collection Development Policy, including the American Library Association's Library Bill of Rights, Freedom to Read Statement, and Freedom to View Statement and The Texas Library Association's Intellectual Freedom Statement.

All meetings of the Library Board are open to the public and are posted according to the Texas Open Meetings Law. Complainants will be notified in writing of the Library Board's decision in the matter.

Thank you for your interest in Tyler Public Library and submitting a Request for Reconsideration regarding your concern for Sold by Patricia McCormick. A copy of your Request for Reconsideration, as well as a copy of the Library's Collection Development Policy for Reconsideration Appeals process, are attached hereto. Per our process as described in the Library's Policy, the request and item was reviewed by the Collection Development Review Committee ("Committee") and the results of the review are as follows.

The Tyler Public Library first added this book to its Young Adult section, separate from our children's area, in February of 2007 on the basis that it met the following specific criteria, set forth in the adopted Collection Development Policy:

- The work was judged on the basis of the work as a whole, not a part taken out of context.
- The work was reviewed favorably in professional journals such as Kirkus, Publisher's Weekly, School Library Journal, and Voice of Youth Advocates
- The work had already obtained several recognitions including the following:
  - Publishers Weekly, Best 100 Books of 2006
  - National Public Radio's Best Books of the Year 2006
  - American Library Association, Top Ten List, Best Books of the Year, 2006
  - Booklist 2006 Editor's Choice Award
- Popularity of the author

Library staff consider professional reviews, awards, and credentials in the process of selecting materials for the collection and each area of the Library. Prior to its addition to the Library, Sold had received several favorable reviews by professional journals and awards. Since its inclusion within the collection, it has gone on to receive a number of other recognitions including the Gustav-Heinemann Peace Prize of 2009 and Children's Literature Council's Choice award.

As of this date, Tyler Public Library has one copy which is housed within our Young Adult collection and has circulated 45 times. Kirkus recommends the title to teen and young adult audiences while others recommend middle grade and young adult. Per publishers and professional review journals, the Library chose to house the item within the Young Adult section which holds materials recommended for ages 14+ or High School and Young Adult audiences.

A rating website, Common Sense media, collects ratings and reviews from both parents and kids. According to this website, these groups rate it appropriate for the following: Rated for ages 13+ by Kids on Common Sense Media; Rated ages 16+ by Parents on Common Sense Media; and Rated ages 14+ by Common Sense Media. While the subject matter is heavy and serious, the City Committee responsible for reviewing your request for reconsideration determined, in accordance with the Library's Collection Development Policy, that Sold by Patricia McCormick is appropriately placed within the Young Adult section as it meets several qualifications already listed and it is concerned with a subject that even American children have faced.

The Tyler Public Library believes that it is important for caregivers, parents, guardians, and grandparents to be guides to their children for the materials they check out. Per the Library's Circulation Policy, parents (or legal guardians) wishing to restrict their children's borrowing of library materials may do so at any time. We understand that not all persons will agree on what should be available to whom, the City of Tyler is bound by federal court decisions regarding the First Amendment, and no one set of beliefs or values can serve as the lens for developing a well-rounded library collection. However, the Tyler Public Library respects all citizen comments and seeks to serve the entirety of the City of Tyler while also making memberships available for purchase to those who reside within Smith County.

In conclusion, the Tyler Public Library finds that the inclusion of Sold by Patricia McCormick within the Tyler Public Library's Young Adult collection is in accordance with the Library's Collection Development Policy. Accordingly, the City's Committee has determined that Sold should remain shelved in the Young Adult collection (ages 14+).

As outlined within our Collection Development Policy, if you disagree with the City Librarian and the Committee's decision as explained herein, you may appeal the decision to the Library Board who will review the request within 90 days. Per Section VIII. of the Collection Development Policy:

In making its decision, the Library Board will consider professional reviews and will employ all of the criteria of selection listed in the Library's Collection Development Policy, including the American Library Association's Library Bill of Rights, Freedom to Read Statement, and Freedom to View Statement and The Texas Library Association's Intellectual Freedom Statement.

All meetings of the Library Board are open to the public and are posted according to the Texas Open Meetings Law. Should you wish to appeal this matter, you are welcome to appear and/or speak at a Library Board meeting. Complainants will be notified in writing of the Library Board's decision in the matter.





If you are dissatisfied with the decision, the City of Tyler Code of Ordinances, Chapter 1, Article IV, Sec. 1-33 (copied below), sets forth the process to appeal this decision to the City Manager for a final decision.

#### Sec. 1-33. Procedure before City Manager or designee.

a. Any person aggrieved by the decision of a Department Leader or designee may appeal such decision to the City Manager. Such appeal must be filed with the City Manager within thirty (30) business days after the decision of the Department Leader or designee, otherwise, the decision of the Department Leader or designee is final.

No employee serving on the advisory group shall be the decision maker whose decision is being appealed. "Appropriate City board" shall mean one of the specific City Boards established by the City Council in Section 1-20, and having objectives or functions associated with the specific City Department to which the appeal was made. The advisory group or City board to which the matter is referred shall consider the matter within sixty

(60) business days after the matter is referred to it, and shall provide a recommendation to the City Manager or designee. All considerations under this Article by a City board shall be in a public hearing. The City Manager or designee shall render a decision within ten (10) business days after the appropriate advisory group or City board gives its recommendation. (Ord. No. 0-98-45, 5/27/98) (Ord. 

Thank you for your interest in Tyler Public Library and for submitting a Request for Reconsideration regarding your concern for *Ramona Blue* by Julie Murphy. A copy of your Request for Reconsideration is enclosed. Per our process as described in the Library's Policy, the request and item were reviewed by the Collection Development Committee ("Committee") and the results of the review are as follows.

The Tyler Public Library first added this book to its Young Adult collection (ages 14+, or High School and Young Adult audiences), separate from its Children's collection (birth – age 18), in May of 2017 on the basis that it met the following specific criteria as outlined in the adopted Collection Development Policy:

- The work was reviewed favorably in professional journals such as Publisher's Weekly, Kirkus, and School Library Journal
- Awards and recognition and/or popularity of the author
  - Cybils Award nominee, 2017, Young Adult Fiction
  - New York Times bestselling author
- Harper Collins/Balzer Bray markets this book as a Young Adult read, which matches review recommendations for age content level being 14+
- The work was judged on the basis of the work as a whole, not a part taken out of context.

Library staff consider professional reviews, awards, and credentials in the process of selecting materials for each collection and area of the Library. Library staff also take recommendations through the public input process, Request to Buy. When reviewing material for younger audiences Library staff also review age content recommendations. Professional reviewers have rated the content of this work for high school and up. The Library chose to house this book within the Young Adult section which holds materials whose content recommendation is ages 14+ or High School and Young Adult Audiences. Since its inclusion within the Young Adult Section, the book has circulated 14 times.

While the book has some mature content regarding family life and relationships, the Committee responsible for reviewing your request determined, in accordance with the standards established in the Library's Collection Development Policy, that *Ramona Blue* by Julie Murphy is appropriately placed within the Young Adult section (separate from the Children's section) as it meets several qualifications already listed.

The Tyler Public Library believes that it is important for caregivers, parents, guardians, and grandparents to be guides to their children for the materials that they check out. Per the Library's Circulation Policy, parents (or legal guardians) wishing to restrict their children's borrowing of library materials may do so at any time. We understand that not all persons will agree on what should be available to whom, the City of Tyler is bound by federal court decisions regarding the First Amendment, and no one set of beliefs or values can serve as the lens for developing a well-rounded library collection. However, the Tyler Public Library respects all citizen comments and seeks to serve the entirety of the City of Tyler.



  - o School Library Journal Best Books of the Year, 2017
  - o International Latino Book Awards, 2017
- The work was judged on the basis of the work as a whole, not a part taken out of context
