- Early 2023, I formally submitted a Request for Reconsideration to the Tyler Public Library asking that the book All Boys Aren't Blue be moved from the youth section to the adult section.
- My request was denied.
- On Sunday, April 16, 2023, I submitted an email request to appeal the decision. On April 17th, I received confirmation from the librarian, Ashley Taylor, that my request was received.
- The scheduled April Library Board Meeting was canceled.
- On Wednesday, May 17th, I received an email from Ms. Taylor informing me

that the library board meeting was scheduled for June 21st. If I had a visual presentation I needed to submit it 48 hours in advance to ensure there were

no technical difficulties.

- On Monday, June 19th, I submitted my powerpoint presentation.
- Just past noon on Tuesday, June 20th, Ms. Taylor sent me an email informing

me that she was forwarding my presentation to the legal department for review because she believed much of it was not pertinent.

 At 8:30 pm, the night before the meeting, she emailed me and said they would

have printed out copies of my presentation for the board. I asked specifically if

the powerpoint equipment would be available, and she never answered.

- There was no equipment available for me at the meeting on June 21st.
- Immediately after the meeting ended, I asked the city attorney, Deborah Pullman, why the legal department didn't approve my presentation. She informed me that, in fact, they had approved my presentation. The decision not to allow me to present was the librarian's.

- 1) To what in the item do you object? Please be specific, citing pages: Page 266: "He reached his hand down and pulled out my dick. He quickly went to giving me head." Page 268: "I remember the condom was blue and flavored like cotton candy. I put some lube on and got him up to his knees, and I began to slide into him from behind. I tried not to force it because I imagined it might be painful; I didn't want this moment to be painful. So I eased in, slowly, until I heard him moan."
- 2) Page 271: "There is a fear, as with most things you are doing for the first time. But this was my ass, and I was struggling to imagine someone inside me. And he was...large. But, I was gonna try."
- 3) In addition, there is an undeniable theme of Critical Race Theory throughout the book. The author doesn't deny it. It must be viewed in that light as well, because it is not just a memoir. It is also a manifesto.
- 4) What do you feel might be the result of using this material? In an interview with CBS News, the author states, "ITIhe book is geared towards young adults, between ages 14 to 18." The section in the library where the book is located is geared for 12-18 year olds. Are discussions of cotton candy condoms appropriate? Painful

- anal sex? Giving head? Are we really supposed to pretend that conversation does not breed curiosity? ESPECIALLY about a topic that brings it's own powerful curiosity?
- 5) For what age group would you recommend this material? Not 12 year olds. I believe adults can certainly make their own choices about what they choose to read, but don't believe it's necessary for tax dollars to provide it.
- 6) Can you recommend anything good about this material? It's actually poorly written. There are basic grammar errors in several areas that left me asking, "Did the editor get fired?"
- 7) Did you read, view or listen to this item in its entirety? Yes.
- 8) Are you aware of the reviews received by this material? The librarian will be happy to help find them This is not the first book reconsideration I have done. My previous experience does cast doubt on whether or not it is worth the effort, but as the saying goes, "The only thing necessary for evil to triumph is for good men to do nothing." I have found the librarian and city manager to be un-engaging and not a reflection of the demographics of East Texas. The library board is an unimpressive, boring group of women who appear to be there to rubber stamp whatever the librarian (who is un-engaging and comes across as far closer in philosophy to the blatantly left-leaning ALA than the right-of-center citizenry of Tyler, Texas) wants. There is a great need in this country for thinking people to be able to discuss decency. Are the passages I quoted considered decent by most people? Are they appropriate for any section in the library that adolescents and teenagers are encouraged to use? I hope there can at least be a satisfying discussion about that.



Dear Ms. Robin Lee,



Thank you for your interest in Tyler Public Library and submitting a Request for Reconsideration regarding your concern for *All Boys Aren't Blue* by George M. Johnson. A copy of your Request for Reconsideration, as well as a copy of the Library's Collection Development Policy for Reconsideration Appeals process, are attached hereto. Per our process as described in the Library's Policy, the request and item were reviewed by the Collection Development Review Committee ("Committee") and the results of the review are as follows.

The Tyler Public Library first added this book to its Young Adult section, separate from our children's area, in July of 2020 on the basis that it met the following specific criteria, set forth in the adopted Collection Development Policy:

- The work was judged on the basis of the work as a whole, not as a part taken out of context.
- The work was reviewed favorably in professional journals such as Kirkus, Publisher's Weekly, and School Library Journal
- Awards and recognitions of the work and author
  - NYT Bestseller
  - Author obtained several awards for other works
- Popularity of the author

Library staff consider professional reviews, awards, and credentials in the process of selecting materials for the collection and each area of the Library. Prior to its addition to the Library, *All Boys Aren't Blue* had received several favorable reviews by professional journals being recommended for ages 14+. The work has also received recognition as a New York Times Bestseller, Texas TAYSHAS Reading List Title, 2021 Texas Topaz Nonfiction Reading List Pick, and more.

As of this date, Tyler Public Library has one copy which is housed within our Young Adult collection and has circulated 10 times. Per publishers and professional review journal recommendations, the Library chose to house the item within the Young Adult section which holds materials recommended for ages 14+ or High School and Young Adult audiences.

While the subject matter is heavy and serious, the City Committee responsible for reviewing your request for reconsideration determined, in accordance with the Library's Collection Development Policy, that *All Boys Aren't Blue* by George M. Johnson is appropriately placed within the Young Adult section as it meets several qualifications already listed and is concerned with subjects that young adults have faced.

The Tyler Public Library believes that it is important for caregivers, parents, guardians, and grandparents to be guides to their children for the materials they check out. Per the Library's <u>Circulation Policy</u>, parents (or legal guardians) wishing to restrict their children's borrowing of library materials may do so at any time. We understand that not all persons will agree on what should be available to whom, the City of Tyler is bound by federal court decisions regarding the First Amendment, and no one set of beliefs or values can serve as the lens for developing a well-rounded library collection. However, the Tyler Public Library respects all citizen comments and seeks to serve the entirety of the City of Tyler while also making memberships available for purchase to those who reside within Smith County.

In conclusion, the Tyler Public Library finds that the inclusion of *All Boys Aren't Blue* by George M. Johnson within the Tyler Public Library's Young Adult collection is in accordance with the Library's Collection Development Policy. Accordingly, the City's Committee has determined that *All Boys Aren't Blue* should remain shelved in the Young Adult collection (ages 14+).

As outlined within our Collection Development Policy, if you disagree with the City Librarian and the Committee's decision as explained herein, you may appeal the decision to the Library Board who will review the request within 90 days. Per Section VIII. of the Collection Development Policy:

In making its decision, the Library Board will consider professional reviews and will employ all of the criteria of selection listed in the Library's Collection Development Policy, including the American Library Association's Library Bill of Rights, Freedom to Read Statement, and Freedom to View Statement and The Texas Library Association's Intellectual Freedom Statement.

All meetings of the Library Board are open to the public and are posted according to the Texas Open Meetings Law. Should you wish to appeal this matter, you are welcome to appear and/or speak at a Library Board meeting. Complainants will be notified in writing of the Library Board's decision in the matter.



### Dear Mayor Warren and Tyler City Council Members,



Attached you will find several of the Book Reconsideration Forms that were recently submitted to the Tyler Public Library Director and to several City Council Members.

These books and many others like them continue to be made available to minors in the Tyler Public Library. It is extremely disturbing to know that the Library Director - the person with the discretion to purchase, reject or remove these books - <u>continues to willfully place these books in the very section of the library dedicated to minors: the teen section.</u>

At this Juncture, we don't want to assume that the City of Tyler is intentionally promoting this pornography directly to our children.

Tyler citizens have become informed and educated about what is going on at the Tyler Public Library. Parents of all religious, ethnic and political backgrounds are now actively involved in this issue. They are understandably outraged at the obscene, sexually graphic and vulgar material that is currently shelved in areas of the library where minors have easy access.

Exposure to pornography is not trivial. It can have traumatic effects leading to significant distress, disruptive behaviors, compulsive sexuality and even suicidal attempts. (1)

Any reasonable person would question the intent behind willfully placing such despicable materials in the teen section. As our elected officials, you are accountable for the management of the Library. Tyler taxpayers are turning to you to take principled action and enforce the community standards that will ensure the safety and well being of our children.

Thank you for your strong interest in the Tyler Public Library and your appeal request submitted on behalf of the appellant Ms. Robin Lee. As allowed by written Library policies, the Library Board conducted a public hearing to consider the appeal regarding the book, *All Boys Aren't Blue*, which was held at the Tyler Public Library on June 21, 2023. At that public meeting, the Library Board voted to deny the request to remove the book from the young adult section of the Tyler Public Library collection.

Pursuant to the Administrative Appeals Procedure established in Tyler City Code Chapter 1, Article IV., I have reviewed your appeal of the Library Board's ruling issued June 21, 2023. After considering your arguments, it is my official decision pursuant to Tyler City Code Sec. 1-33 to move the book, All Boys Aren't Blue, to the adult section of the Tyler Public Library.

The Tyler Public Library serves the entirety of Tyler's citizens while also making memberships available for purchase to those who are not citizens but reside within Smith County. Our overall goal is to develop a well-rounded library collection while remaining compliant with federal court decisions related to Free Speech and the First Amendment to the U.S. Constitution.

Good Morning,

I hope this email finds you well.

I am writing about your article in the paper covering the Tyler Public Library.

My name is Robin Lee. I submitted the one request to have a book removed from the library, and the request for the book <u>All Boys Aren't Blue</u> by George M. Johnson to be relocated to the adult section of the library. As such, I feel I am qualified to speak into this.

I think you might benefit by reading the DIRTY THIRTY campaign emails.

I noticed that there are none of the controversial passages quoted in your article--likely because the language is so vulgar it would not be allowed, and also because it could be deemed "prejudicial", in that it is stunning language to argue for keeping in the youth section.

There are some gaps and inaccuracies in your article.

1.) ALL BOYS AREN'T BLUE was not relocated based on my request. The librarian and her committee denied the request to move it to the adult section. The library board also denied the request to move it to the adult section.

For reasons that are unknown to me and were done in secret, my understanding is that Ed Broussard ordered the book to be moved.

Why? What standard was he maintaining that the entire established process of the library had denied?

I was told, the day before my library presentation, that the librarian was submitting my presentation to the legal department for approval because, according to her, much of it was not pertinent. (I, of course, disagree with her assessment.) At 9 pm that night, I got an email telling me they would make color copies of my presentation for the board.

I was not allowed to use the equipment for my powerpoint. I asked the city attorney directly why my presentation was not allowed. The legal department had no problem with my presentation—it was the librarian's decision not to allow me to present it.

In other words, in her fight against "censorship", she censored me.

Here is a quote from the book: "He pulled out my dick and quickly started giving me head...I could tell he was enjoying it, as was I."

2.) The library committee that decides the Reconsideration Requests is not required to read the book. We have that verified through emails gathered from a Public Information Request.

When the library board denied my request for reconsideration, it was asked if the board had read the book. Only one board member had.

3.) The book I requested to be removed was <u>Blue Is The Warmest Color</u> by Jul Maroh. This was based on the premise that cartoon depictions of graphic sex acts should be considered pornography.

It was that straight forward.

4.) Any implication that the concerns are due to LGTB content is inaccurate.

There is no concern with George M. Johnson's second memoir <u>We Are Not Broken</u>. He wrote it as a tribute to his grandmother, and the use of language and stories reflects a much more respectful tone,

5.) Several of the books they moved to the adult section had been reclassified by the publisher as adult material. The library had been informed, by the publisher, years earlier that the youth designation was not appropriate.

The books were moved only when the public got involved.

I think that is a key piece of information.

I understand that not everyone is going to see the books being questioned as pornography-because the "graphy" portion is based on words rather than images. I also am a fierce advocate against removing classics such as <u>To Kill A Mockingbird</u> and <u>Huckleberry Finn</u>.

But, an honest discussion demands acknowledging that the language and content we are asked to accept in the youth section is a wild departure from long-held societal norms. Stories about watching your teeth while performing oral sex on a man, and cotton-candy flavored, blue condoms would never have even been considered appropriate for a teen section in the past.

This is not about difficult stories and reading content. It is about pervasively vulgar, sexually explicit content.
